SCOTTISH LAW COMMISSION ANNUAL REPORT 2003 (Scot Law Com No 194)

The Scottish Law Commission's Annual Report for 2003 is published today. The report marks the launch of the Commission's new corporate identity, which is aimed at developing a more modern public image consistent with the values that underpin the Commission's law reform work.

The report outlines the progress which the Commission made in 2003 with its law reform projects and details the reports and discussion papers planned for 2004.

2003 was a productive year during which the Commission published three discussion papers, inviting comments on provisional proposals for reform of particular areas of the law, and four reports, containing final recommendations for reform. Two of the reports were published jointly with the Law Commission for England and Wales.

In his Foreword, the Chairman of the Commission, the Hon Lord Eassie, pays tribute to Patrick Hodge QC whose term of office as a Commissioner ended in April 2003 and welcomes Colin Tyre QC, who became a Commissioner in October 2003.

The report outlines progress on the Commission's current law reform projects, including those on property law, psychiatric injury, unfair terms in contracts, insanity and diminished responsibility, and trusts. It lists 10 publications planned for 2004.

The report also describes the Commission's other activities in promoting law reform and provides information about recent legislation that has implemented some of the Commission's earlier recommendations for reform.
