# Contract (Third Party Rights) (Scotland) Act 2017

The Contract (Third Party Rights) (Scotland) Act received Royal Assent on 30 October 2017, and implements recommendations by the Commission in the 2016 Report on Third Party Rights. The Commission gave evidence on the Bill to the Delegated Powers and Law Reform Committee in March.

#### **Delegation from China**

In September the Commission met the Legislative Affairs Commission of the National People's Congress of China, and discussed law reform processes.



#### **Tenth Programme of Law Reform**

A consultation on our Tenth Programme of Law Reform was carried out earlier this year. The responses are on our website <a href="here">here</a>.

The Commission is considering the responses carefully, and discussing them with the Scottish Government. A draft Tenth Programme will be prepared for approval by Scottish Ministers by the end of this year.

#### **Report on Prescription**

# **Discussion Paper on Remedies for Breach of Contract**

The Discussion Paper on Remedies for Breach of Contract was published in July - see <a href="here">here</a>. The Commission is considering the comments received.

## Recent consultations

The Commission consulted recently on a working draft of a Bill on the formation of contract law. A final report (on formation, interpretation, penalty clauses and remedies for breach) will be published in 2018.

The Commission also consulted recently on working drafts of a Defamation and Malicious Publication (Scotland) Bill, and a Moveable Transactions (Scotland) Bill. The Commission is considering the responses, and working on a Report on each of these topics.
