## HOMICIDE LAW REFORM – LAW COMMISSION TEAMS UP WITH STRATHCLYDE LAW SCHOOL

In another example of the increasing collaboration between the Law Commission and the Scottish law schools, Dr Claire McDiarmid today joins the homicide team at the Commission from the University of Strathclyde. Dr McDiarmid will work for several months as part of the team developing a Discussion Paper on the mental element of homicide. The homicide law reform project forms part of the Commission's 10<sup>th</sup> Programme of Law Reform announced in February 2018.

The arrangement takes place under the Memorandum of Understanding between the Scottish Law Commission and the Scottish Law Schools agreed in 2016.
