



Revised determination by the Presiding Officer for referring Commission Bills to the DPLR Committee

The Commission welcomes the revised determination by the Scottish Parliament's Presiding Officer of the criteria for referring Commission Bills to the Delegated Powers and Law Reform (DPLR) Committee of the Scottish Parliament: Parliament's Business Bulletin. The will revised determination facilitate improvement in the rate of implementation of Commission Bills in Session 6 of the Parliament.

The DPLR Committee published a <u>handover</u> report recommending that its successor committee take the time to learn more about the Commission's work, and develop links with the Commission.

The Commission appreciates the work of the Committee on Commission Bills, and the process for the Bills, and looks forward to engaging with the successor committee.

Publications

Automated Vehicles



A joint consultation paper by the Scottish Law Commission and the Law Commission of England and Wales on new laws for automated vehicles was published on 18 December 2020. This is the third (and final) consultation paper in the project. It sought views on various matters including the definition of self-driving, safety assurance before and during use, responsibilities of users, civil and criminal liability and access to vehicle-use data. All of the consultation papers are available on the project page of our website.

A number of discussions were held with interested parties during the most recent consultation period and we are grateful to all those who took part and to those who have submitted a written response. The consultation closed on 18 March 2021. A joint team is analysing all of the responses and the Commissions aim to publish a report with full recommendations by the end of 2021.

Annual Report

The Commission published its <u>Annual Report</u> for 2020, in February 2021. The Report outlines the wide-ranging law reform work carried out by the Commission during 2020, and describes the progress made on its projects. It also records publications planned for issue in 2021 including Discussion Papers on homicide, damages for personal injury, and heritable securities, and Reports for issue in 2021/2022 including cohabitation, automated vehicles, and termination of commercial leases.

Implementation

The Defamation and Malicious Publication (Scotland) Act 2021

The Defamation and Malicious Publication (Scotland) Bill received Royal Assent on 21st April. The Act implements the recommendations in the Commission's Report on Defamation (Scot Law Com No 248, 2017).

Lady Paton, Chair of the Commission, said:

"We warmly welcome the enactment of this important legislation. The Act implements key recommendations in the Commission's 2017 Report on Defamation, with a view to modernising the law of defamation and making it fit for purpose in today's society."
